Variation sought relates to clause 4.1.

Fair Work Australia hereby directs as follows:

1. Sealink Travel Group Limited (the applicant) is given leave to amend its application as follows:

Amend sub clause 4.1 Ports, Harbours and Enclose Waters Vessel Award 2010 by inserting the following "on smooth or partially smooth waters" between the words "harbour" and "or" to read:

"For the purposes of clause 4.1, **ports, harbours and enclosed water vessels industry** means the operation of vessels of any type wholly or substantially within a port, harbour, on smooth or partially smooth waters or other body of water within the Australian coastline or at sea on activities not covered by other awards."

- 2. The applicant is by **Friday 26 October 2012** to file with FWA further and better particulars concerning the application including the intended meaning and import of the expression "on smooth or partially smooth waters".
- 3. The Maritime Union of Australia, the Australian Institute of Marine and Power Engineers, Business SA and any other organisation or person seeking to be heard in relation to the application are by **Monday 5 November 2012** to file with FWA an outline of their position and any cross-applications.
- 4. The applicant is by **Friday 16 November 2012** to file with FWA an outline of argument, documentary material and affidavits in support of its application.

- 5. A further directions conference will be conducted by Fair Work Australia on **Monday 26 November 2012 at 10.00am** (ACDT) (see separate notice of listing).
- 6. Liberty to apply is granted generally.
