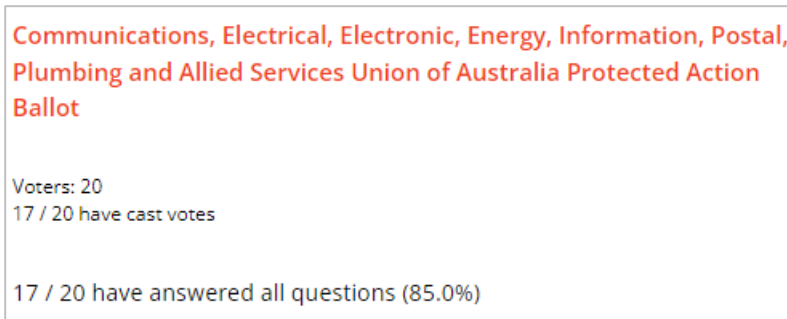

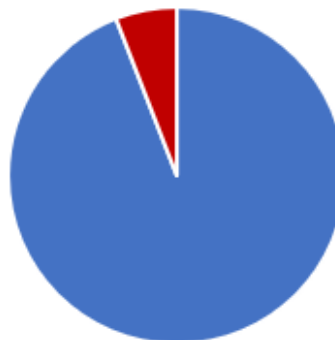
Question 1

■ No - 1 (6%)



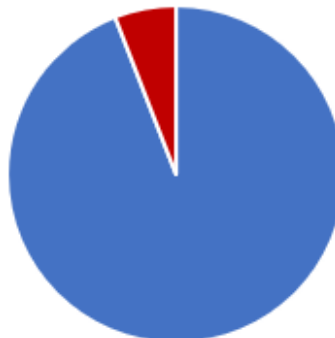
Question 2

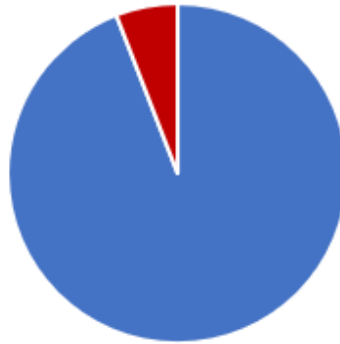


Question 3

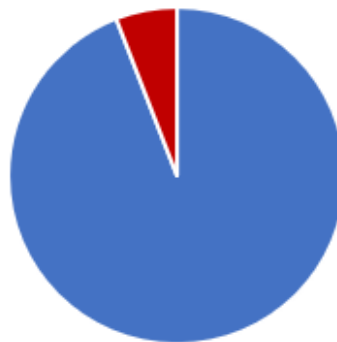

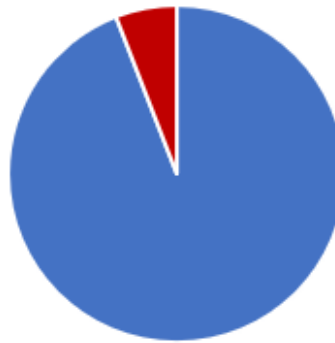
