Option 1:

In terms of general information about the 4 yearly review, it might be useful to subscribe to updates through the Commission's website. There are two subscription options:

- [Subscribe to updates](#) to the **My awards—All matters** service to receive email notifications when documents are posted to the modern awards pages of the Commission's website. Please note that even if you subscribe to only receive updates in relation to matters affecting the **XX Award**, you will receive numerous emails (up to 2 a day) that relate to other awards
- Subscribe to the **Award modernisation information** announcements service. This is a lower volume email service but only notifies subscribers when 'significant' documents are issued.

Option 2:

If you haven't already, we recommend subscribing to our email updates. These subscription emails are the primary way we communicate with interested parties when an award is updated or when information about award related proceedings is published on our website.

There are two types of award subscription options available to clients. Award updates and award matters.

1. My awards—Updates

By subscribing to **My awards—Updates**, you will receive an email when an award has been updated, or when a document has been issued about an award that does not vary the award (such as a decision).

2. My awards—All matters

By subscribing to **My awards—All matters**, you will receive an email when an application to vary a modern award has been lodged or an award is being reviewed, and when any associated material is issued or received. This includes information about proceedings, submissions, hearing details and decisions. You will also receive any emails dispatched through the awards Updates service for your selected awards.

*NOTE: This is a high volume service and you may receive emails about awards other than those for which you have subscribed.
