Further to the Decision of [XXX] issued on [date], the above award is varied as follows:

1. Amend Schedule B:

- 1.1. by deleting Clause B.1.1 and inserting in lieu thereof "For the purposes of Schedule B, the ordinary hourly rate includes the industry allowance (clause 17.2(a)), which is payable for all purposes. For the purposes of the rates prescribed for Electrical Worker Grade 5 and above, the ordinary hourly rate also includes the tool allowance (clause 17.2(g)), which is payable for all purposes."
- 1.2. by deleting from the heading of Clause B.2.1 the words "and penalty" and deleting the final column in the table headed "Public Holiday"
- 1.3. by amending the table at clause B.2.4:
 - 1.3.1. adding an additional row containing the words "% of ordinary hourly rate" after the row starting with "First 2 hours" and before the row starting with "200%".
 - 1.3.2. Delete the first row and replace by creating new headings:
 - 1.3.2.1. in the first row adding the words "Monday to Sunday" in the second column above the cell containing the words "Continuous Shift Work".
 - 1.3.2.2. In the first row adding the words "Monday to Saturday" over the third, fourth columns above the cells containing the words "Other than Continuous Shift Work".
 - 1.3.2.3. Adding a new column, column five, between the new "Monday to Saturday" and the column headed "Public Holiday" and in the first row/heading insert the word "Sunday". This will sit above the wording "Other than continuous shift work" in the fifth column.
 - 1.3.2.4. Insert into column five the dollar amounts for 200% for the appropriate grades contained in columns two and four.
 - 1.3.2.5. Insert under the first row heading in the final column "Public Holiday" another column. Insert into row two under the "Public Holiday" heading the words "Continuous shiftwork" in column six and "Other than continuous shiftwork in column seven.

1.3.2.6. Move the existing dollar amounts and 250% into column seven and copy the 200% dollar amounts in columns two, four and five into the column six under Continuous shiftwork".
