In response to your email to all the parties in connection with the Plumbing and Fire Sprinklers Award modern award review process and dated 21<sup>st</sup> July 2017, Fire Protection Association Australia seeks to refer to two matters in connection with this matter which are:

1. Shift work proposal – following a discussion between some of the parties which are referred to in an email to the Fair Work Commission dated 1<sup>st</sup> March 2017, FPA Australia indicated that a shift work proposal had been forwarded to all the respective parties. To date no response has been forthcoming. We there respectfully request that the Commission assist the parties with respect to this matter on 17<sup>th</sup> August 2017. In the meantime, an attempt will be made to seek responses from the respective parties unless any such response follows these comments.
2. Industry Disability Allowance – this matter refers to paragraph 20.3 (f) of the Award. There has been some exchange between respective parties and while there appears to be some consensus between those parties, there does not appear to be any finality of this matter. It would seem, however, that this matter should be capable of resolution. Accordingly, this matter may only require the Commission's involvement to confirm agreement.

We trust that this outline assists the Commission.
