The material should include a draft determination and/or a draft award with the modern award terms and conditions which are proposed to apply to Helicopter Aircrew if Modern Award System Coverage is extended to include them.
- 3. Any party supporting the proposed extension of Modern Award System Coverage to Helicopter Aircrew must also lodge their comprehensive written submissions, any witness evidence and documentary material upon which they rely by **31 July 2017**.
