# Mr Josh Martin Associate to Vice President Catanzariti AM Fair Work Commission

Dear Associate

We refer to APESMA's application to vary the above Award to include Translators and Interpreters in the Common List of Health Professionals (Schedule C in the current version of the Award).

We confirm that at the hearing of this matter on 11 December 2017 Vice President Catanzariti and Deputy President Booth requested that relevant parties consider resolution of APESMA's application on the basis the occupations of Translator and Interpreter continue to sit in the support services stream, but continue to have award coverage if individuals performing those occupations move around to other industries. (see PN669 to PN717 of the Transcript for Monday 11 December 2017).

On 23 January 2018 we sent an email to all parties involved in the four yearly review of the Award seeking agreement or expressions of opposition to a suggested variation to Clause 4 (Coverage) of the Award. In our submission, the suggested variation would, we submit, achieve the resolution envisaged by Vice President Catanzariti and Deputy President Booth at the hearing on 11 December 2017.

On 31 January 2018 we received an email in response from Mr Kyle Scott from Australian Business Lawyers (ABL) on behalf of ABI and NSW Business Chamber. Mr Scott advised the proposal (to vary the coverage clause of the Award) would be discussed at the next ABI Council meeting which is to be held on 21 February 2018.

Please note that our email of 23 January 2018 and the email of ABL of 31 January 2018 are attached to this email (see below).

To date we have received no other responses from parties to the Award to our email of 23 January 2018.

With a view to exploring the possibilities of achieving resolution of our application by agreement between the parties, and subject to the Direction of Vice President Catanzariti and the Full Bench, we request that APESMA's application be the subject of a Conciliation Conference to be listed for a date after 21 February 2018. (Please refer to Vice President Catanzariti's comment at PN673 of the transcript for 11 December 2017 when he queried whether discussions between the parties had been exhaustive or whether a further conciliation should be held.)

In view of our request for Conciliation, we also seek an extension of time for any further comprehensive written submissions to be submitted in accordance with Direction (a) of Vice President Catanzariti's Directions of 21 December 2017 to an appropriate date after the 21 February 2018 and after the date of any Conciliation Conference (should the matter be listed for conciliation Conference).

We look forward to your response at your earliest convenience.
