I represent the Dental Hygienists Association of Australia.

I telephoned your Associate, Joshua Martin this morning, regarding queries I had concerning the Notice of Listing which has been published this morning in relation to the **Health Professionals and Support Services Award 2010**.

I am writing to seek confirmation that in relation to the forthcoming Hearing for this Award:

- . there is no Hearing scheduled for 27 and 28 November as a consequence of the Conference before the Vice President on Friday morning. The two November dates are now the dates now set aside for the Nurses Award. There appears to be an error in the "Note" of the Notice of Listing, but the Listing Details are correct (which are 11-14 December for the Health Professionals Award, subject to a proposed program to be drafted by the parties).
- . that Vice President Catanzariti is sitting in Sydney rather than Melbourne, as per the Note.
- . that all parties may choose to appear via video link and witnesses may be sworn in at any of the Fair Work Commission offices, if appearance of a party is made via video link.
