We refer to the above matter, in which we act for Fairfax Media Publications Pty Ltd, Rural Press Pty Ltd, and various associated entities of each which have an interest in the review of the *Journalists Published Media Award 2010 (Award)*.

Our clients respectfully request that they be granted an extension to file their evidentiary materials and submissions in response to the MEAA's proposed variations until 5:00 pm on 8 July 2019. In this respect, we can advise the Commission that on 1 July 2019, the transaction finalising the sale of the Australian Community Media business will take effect, and as a result Rural Press Pty Ltd and various subsidiaries covered by the Award will become entirely separate from our other clients with an interest in the review of the Award. The granting of an extension which takes the filing deadline past the completion of the sale will allow us to confirm our instructions and finalise our clients' evidentiary materials having regard to the new corporate arrangements and the availability of key personnel.

Our clients do not believe that the extension sought will occasion any prejudice to other interested parties, noting the time until the listed directions and final hearing dates and the previous granting of an extension to the MEAA to file its own materials.
