BACKGROUND

- On 14 October 2019, the Full Bench issued a decision [2019] FWCFB 6861¹ regarding the process for the finalisation of exposure drafts for tranche 2 awards ("the October 2019 Decision").
- 2. The October 2019 Decision invited interested parties to comment on its *provisional* view regarding the Tranche 2 Exposure Drafts and the associated draft variation determinations, with submissions to be filed by 4:00pm, 25 November 2019.²
- 3. The CFMMEU Manufacturing Division ("CFMMEU MD") provides the following submissions in relation to the Dry Cleaning and Laundry Industry Award 2010.

DRY CLEANING AND LAUNDRY INDUSTRY AWARD 2010 ("Dry Cleaning Award")

- 4. On 14 October 2019, a further revised Exposure Draft³ and draft variation determination⁴ were published with respect to the *Dry Cleaning Award*.
- 5. These submissions are directed towards the form of the Exposure Draft specifically. However, they equally apply to the form of the Draft Determination.

Clause 11.8 – Right to request casual conversion

6. At sub-clause11.8(i) of the Exposure Draft it states in the second paragraph:

If the employee does not accept the employer's refusal, this will constitute a dispute that will be dealt with under the dispute resolution procedure in clause 33 – Consultation about changes to rosters or hours of work.

7. This would appear to be an incorrect reference. It should refer to 'clause 34 – Dispute Resolution'. This would be consistent with the wording of the current clause 10.6(i) in the Dry Cleaning Award.

Clause 20 – Allowances

8. The following note appears twice in clause 20 of the Exposure Draft (before sub-clause 20.1 and following sub-clause 20.3(d):

NOTE: Regulations 3.33(3) and 3.46(1)(g) of Fair Work Regulations 2009 set out the requirements for pay records and the content of payslips including the requirement to separately identify any allowances paid.

- 9. We submit that the Note should appear only once in clause 20.
- 10. We submit that the proposed amendments be made to the Exposure Draft and the draft determination for the *Dry Cleaning Award*.
