Subject: 4 Yearly Review of Modern Awards: Casual/Part-Time Full Bench proceedings (AM2014/196, AM2014/197)

Dear Associate

We refer to the casual/part-time employment Full Bench proceedings (AM2014/196, AM 2014/197) and the variations being pursued by St Ives Group and our clients, Australian Business Industrial and the NSW Business Chamber, to the *Social, Community, Home Care and Disability Services Industry Award* which have been set down for hearing on 14 and 15 July 2016.

During a conference conducted by DP Booth on 3 June 2016 in relation to the individual award stage of the review of the *Social, Community, Home Care and Disability Services Industry Award*, parties discussed the casual/part-time Full Bench proceedings and indicated a willingness to participate in a conciliation to explore whether the issues in dispute between the parties might be able to be narrowed.

Accordingly, we write to request that the Commission facilitate a conference in relation to 'the NDIS' claims (those appearing at item 4B of the Draft Program attached to the Directions of 9 March 2016).

We have canvassed the views of the interested parties who participated in the conference before DP Booth, and can confirm that all parties have indicated support for a conciliation, subject to:

- The conciliation taking place before the July hearing dates; and
- The hearing proceeding as listed if the matter is not resolved.

In that respect, the parties have tentatively identified 16 June 2016 (following the mention before Vice President Hatcher) and/or 17 June 2016 as being suitable to the parties.
