The CFMMEU seeks that the documents produced in response to category 9 and 10 of the Amended Application are able to be accessed by both the CFMMEU's internal lawyers and external legal representation (Maurice Blackburn Lawyers and counsel).

We note the Vice President's observations that he is only dealing with the question of whether the Commission should order production and not the subsequent question of access to those documents. However, if production is ordered the CFMMEU will undertake, when the CFMMEU seeks access to the documents, that they will only be accessed by Ms Weber and Mr Liley at the premises of Maurice Blackburn Lawyers (at 380 La Trobe Street) and that the documents and the information contained therein will not be transmitted or shared to any CFMMEU email or electronic system.

We trust this resolves the applicant's concern regarding confidentiality.

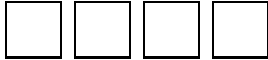
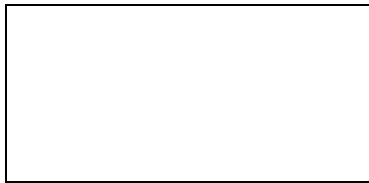
