We refer to the above proceedings, and to the orders made by President Hatcher on 2 August 2023 (**Orders**).

The Health Services Union requires an extension of time to comply with orders 2, 8 and 9 of the Orders, until 22 September 2023 (**Extension Request**).

The Extension Request is sought as a result of unforeseen delays in finalising instructions in relation to the matters which are the subject of orders 2, 8 and 9, in addition to the unavailability of expert witnesses.

The HSU is of the view that the short extension of 1 week will not materially impact the remainder of the timetable as currently set.

We have included the legal representatives for the active parties in these proceedings, in this email.
