Expense-related allowances.

- A. Pursuant to s 157 of the *Fair Work Act 2009*, the above award is varied as follows:
1. By deleting the amount “\$20.89” appearing in clause 18.3(g) and inserting “\$21.81”.
 2. By deleting the amount “\$16.79” appearing in clause 18.5(a)(i) and inserting “\$18.10”.
 3. By deleting the amount “\$376.00” appearing in clause 18.5(b)(i) and inserting “\$383.67”.
 4. By deleting the amount “\$0.91” appearing in clause 18.6(b) and inserting “\$0.95”.
 5. By deleting the amount “\$6.77” appearing in clause 18.6(c) and inserting “\$8.46”.
 6. By deleting the amount “\$22.02” appearing in clause 18.6(d)(i) and inserting “\$27.52”.
 7. By deleting the amount “\$3.95” appearing in clause 18.6(d)(iii) and inserting “\$4.94”.
 8. By deleting the amount “\$0.91” appearing in clause 18.6(f) and inserting “\$0.95”.
 9. By deleting the amount “\$561.05” appearing in clause 18.7(a)(i) and inserting “\$701.21”.

10. By deleting the amount “\$16.79” appearing in clause 18.7(a)(iii) and inserting “\$18.10”.

11. By deleting the table appearing in clause C.2.1 and inserting the following:

B. This determination comes into operation on 1 July 2023. In accordance with s 165(3) of the *Fair Work Act 2009* this determination does not take effect in relation to a particular employee until the start of the employee’s first full pay period that starts on or after 1 July 2023.
