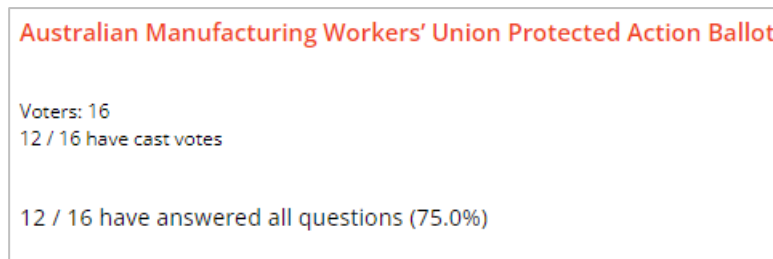
1. Ballot Result

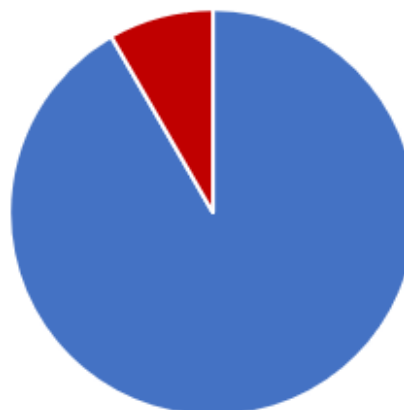

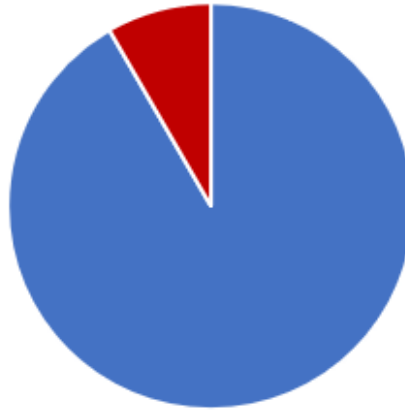

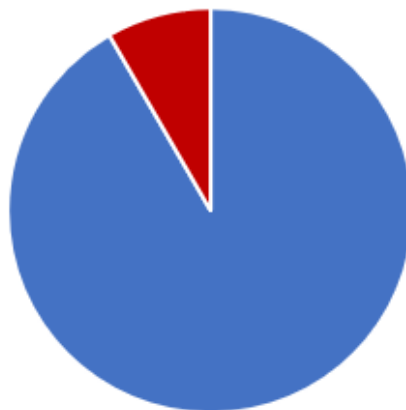

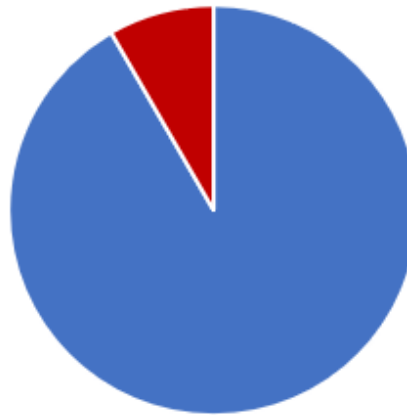

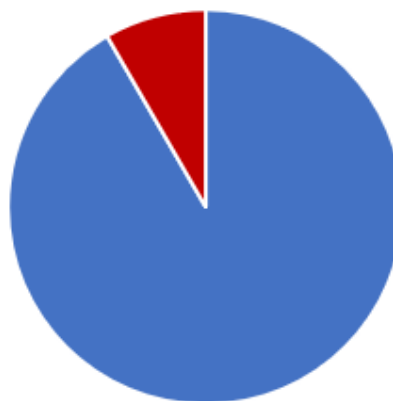
