[1] This Statement relates to a number of substantive claims that have been made to vary the *Children's Services Award 2010* and the *Educational Services (Teachers) Award 2010* which are listed for hearing on **Friday 9 August 2019**.

[2] A <u>Background Document</u> and Statement<sup>1</sup> was issued on 13 June 2019, directing the parties to respond to some 53 questions by 4:00 pm on Friday 5 July 2019. IEU requested an extension to 9 July 2019 which was granted to all parties. The following parties filed submissions in response to those questions:
