4 yearly review of modern awards - Social, community, home care and disability services industry

Further to the Decision and Reasons for Decision of 5 July 2017 in AM2014/196 and AM2014/197, it is determined pursuant to section 156(2)(b)(i) of the *Fair Work Act 2009*, that the *Social, Community, Home Care and Disability Services Industry Award 2010* be varied as follows:

- [1] By inserting the following clause as a new clause 10.3(d):
 - 10.3(d) The requirement to specify the regular pattern of work in clause 10.3(c) does not prevent an employer and an employee from agreeing, either on commencement or subsequently in writing, to arranging ordinary hours in a:
 - (a) pattern spanning a fortnight, month or roster cycle; and/or
 - (b) manner that allows for a specified higher number of hours to be worked at particular times of the year.
