## AM2014/219 - SUBMISSIONS IN REPLY ON OUTSTANDING AND TECHNICAL DRAFTING ISSUES

We act on behalf of Australian Business Industrial (ABI) and the New South Wales Business Chamber Ltd (NSWBC) in respect of the above matter.

ABI and NSWBC each have a material interest in the *Clerks - Private Sector Award 2010*. In accordance with the Directions dated 17 August 2016, set out below are our clients' submissions in reply to those of other interested parties. We also seek to rely upon our submissions filed 6 September 2016.

- Clause 5.2: Our clients agree with the submission of Business SA.
- Clauses 8.1 and 14.1: Our clients agree with Business SA and submit that there may be some
  merit in including a definition of 'shiftworker' in the award. ABI and the NSWBC will consider
  any wording advanced by other interested parties. In the absence of a definition proposed
  by an interested party, our clients do not intend to pursue the issue.
- Clauses 8.1 (a)(i) and 8.1 (a)(ii): Our clients do not oppose Ai Group's proposed amendments to this clause. In this regard we refer to paragraph 5.4 of our submission dated 6 May 2016.
   Our clients disagree with the position of the ASU in this regard.
- Clause 8.2(b): Our clients agree with the submissions of Ai Group and Business SA. In this
  regard we refer paragraph 5.4 of our submission dated 15 April 2016. Our clients disagree
  with the position of the ASU in this regard.
- Clause 13.4 (b)(i): Our clients agree with Business SA and submit that no change is required.
- Clause 14.2: Our clients agree with the position of Business SA and Ai Group and disagree with the submissions of ASU. In this regard, our clients repeat and reply upon paragraph 5.14

- Clause 15.2: Our clients oppose the change sought by the ASU and note that this will be pursued as a substantive claim.
- Clause 15.3: Our clients support the other parties' view that no amendment is required and do not propose to make further submissions.
- 10. Clause 13: Our clients neither support nor oppose the submission of the Ai Group in relation to the deletion of clause 13.4(c) and insertion of a new clause 14.5(c) at this stage and would appreciate the opportunity to further discuss this proposal.

Our clients note the issue raised by the Ai Group in relation to inconsistent terminology being used throughout the document and support further discussion of this issue.
