AM2016/30 Alpine Resorts Award 2010

As you are aware, we act for the Australian Ski Areas Association ("ASAA") in the above matter.

We refer to the Orders made on 24 November 2016 and amended on 6 April 2017 ("Orders"), and the submissions and witnesses statements filed on behalf of the Australian Business Industrial, the New South Wales Business Chamber and the Thredbo Chamber of Commerce ("ABI") on 13 April 2017. The ASAA request that Order 6 be varied to provide a two-week extension of time for filing its reply submissions.

In their submissions, the ABI have raised new issues and produced further evidence on the question of coverage of the Alpine Resorts Award 2010. The reason for the requested extension of time is that in order to properly respond to the ABI submissions, the ASAA and each of its members must review a substantial volume of data and other documentary material. We are further instructed that due to

the recent Easter vacation period, the ASAA member organisations have had limited opportunity since 13 April 2017 to review and collate evidence necessary to prepare its reply submissions. Accordingly, we respectfully request that the ASAA be granted an extension to 11 May 2017 to file its reply submissions.

We also note that in light of the Commission's decision to postpone the Full Bench hearing until October 2017, any extension granted is unlikely to cause prejudice to the other parties to these proceedings.
