We act for CSL Australia Pty Limited (**CSL**) in the proceedings relating to the *Seagoing Industry Award 2010* (**SIA**) which have been referred to the Full Bench (AM2016/5).

We refer to the witness statement of Mr Henning Christiansen filed earlier this week. As you know, CSL opposes AIMPE's application to add the Electrican/Electro Technical Officer classification at the Second Mate/Second Engineer grading in Part A of the SIA, in so far as CSL's position is that this is not the appropriate grading and that an analysis should be undertaken to determine the correct grading for the Electrician/Electro Technical Officer classification.

Given that Mr Christiansen's statement was filed this week, and other parties have therefore had limited time in which to respond, we wish to propose that the parties ask the Full Bench to refer this matter to conference before a single member of the Commission to deal with issues of work value so as not to take up the Full Bench's hearing time with what we anticipate will be a detailed analysis required to determine the appropriate grading. In making this proposal, we also note your advice to the Commission that Mr Christiansen will not be available for the hearing on Monday and Tuesday.
