Thank you for your email, and for our subsequent phone call where you confirmed you were referring to the *Meat Industry Award 2010* (the Meat Award) and the AM2019/17 finalisation of Exposure Drafts and variation determinations – Tranche 2 [Decision](#) issued on 24 December 2019 (the Decision).

The Meat Award is discussed in the Decision at paragraphs [25]; [309] – [321]. To summarise, these paragraphs confirm the correction of minor errors and discuss award specific issues, confirming that various proposed changes will each be made with the variation determination being amended accordingly.

Subsequently, the Meat Award will be amended to correct and make these minor errors and variations, and the final variation determination will be published on 14 February 2020 (see paragraphs [399] – [400]; [402]).

Accordingly, there is no further hearing listed.
