On 16 November 2022, I Phillip John Pasfield of level 14, 55 Market Street, Sydney in the state of New South Wales, Lawyer, state:

- 1. I am a lawyer employed by Slater & Gordon Ltd. I have the care and conduct of this matter on behalf of the Applicant.
- 2. I make this statement based on my own knowledge, except as indicated to the contrary. Where I deal with matters based on information provided to me, I believe that information to be true and correct.
- 3. On 31 October 2022 I received a letter from the lawyers for the CFMMEU seeking production of various documents.

Annexed hereto and marked "PJP1" is a copy of the letter.

4. On 2 November 2022 I sent a reply by email to the lawyers of the CFMMEU.

Annexed hereto and marked "PJP2" is a copy of the email.

5. On 7 November 2022 the lawyers for the CFMMEU lodged in the Commission an application for an order of production of documents, records or information to the Commission (**Application to Produce**).

Annexed hereto and marked "PJP3" is a copy of the Application to Produce and the draft order lodged with it.

6. On 8 November 2022 I sent a letter to the lawyers for the CFMMEU concerning the Application to Produce.

7. On 9 November 2022 I received a letter from the lawyers of the CFMMEU responding to my letter of 8 November 2022.

8. On 9 November 2022, following the receipt of annexure PJP5, I sent an email to the lawyers for the CFMMEU.

Annexed hereto and marked "PJP6" is a copy of that email.

9. On 10 November 2022, I received a reply email from the lawyers for the CFMMEU.

Annexed hereto and marked "PJP7" is a copy of that reply email.

10. On 10 November 2022, following the receipt of annexure PJP7, I sent an email to the lawyers for the CFMMEU concerning the proposed Amended Application being dealt with on an informal basis.

Annexed hereto and marked "PJP8" is a copy of that email.

11. On 10 November 2022 I received a reply email from the lawyers for the CFMMEU to annexure PJP8.

Annexed hereto and marked "PJP9" is a copy of that email together with a further proposed Amended Application to Produce attached thereto.

12. On 10 November 2022 I responded to annexure PJP9 by email.

Annexed hereto and marked "PJP10" is a copy of that email.

13. On 10 November 2022, following my email which is annexure PJP10, the lawyers for the CFMMEU lodged an Amended Application (**the Amended Application**) to Produce and draft order in the Commission.

Annexed hereto and marked "PJP11" is a copy of the covering email to the Commission lodging the Amended Application to Produce and draft order from the lawyers for the CFMMEU.

The Applicant's position in respect of the Amended Application

- 14. The only categories in the Amended Application which are in contention are categories 9 and 10. Mr Kelly's position in respect of each of the categories, and which I have conveyed to the Respondent in the above communications, is as follows.
- 15. Mr Kelly has informed me that there are no documents to produce in respect of categories 1, 2, 4 and 5.
- 16. The document sought by category 3 is in the possession of the CFMMEU. It is annexure GK-20 to the Statement of Mr Kelly dated 25 October 2022.
- 17. The document sought by category 6 is in the possession of the CFMMEU. It is annexure GK-21 to the Statement of Mr Kelly dated 25 October 2022.
- 18. Mr Kelly has offered to voluntarily produce the documents sought by categories 7, 8 and 11 and is agreeable to doing so.
- 19. Mr Kelly has instructed me to oppose the CFMMEU having access to the membership rolls sought in categories 9 and 10 in paragraph 1.1 of the Amended Application.
- 20. Mr Kelly has informed me that the Mining and Energy Division is concerned to protect the privacy of the members whose names, addresses and workplaces are contained on the rolls. The membership details of members is held on a confidential basis.
- 21. Unlike the smaller category of members who forwarded Instruments of Authorisation (being annexure 2 to the Application by Mr Kelly lodged 15 September 2022) who forwarded those authorities freely, Mr Kelly has informed me that members expect that other personal details shall not be disclosed to third parties. I have been informed by Mr Kelly that members often ask officials of the Mining and Energy

- Division whether their membership status and personal details will be disclosed to anyone. I have been informed by Mr Kelly that officials of the Mining and Energy Division are rigorous in advising members that their membership status and personal details contained on membership rolls are not disclosed to third parties.
- 22. Mr Kelly has informed me that he is concerned that producing the membership rolls sought in categories 9 and 10 would be a breach of trust with the Mining and Energy Division's members and that doing so could be damaging to the division.
- 23. This practice is consistent with the provisions of the *Privacy Act 1988* (Cth).
- 24. On 9 November 2022 I made contact with Mr Julius Roe who is a former Commissioner of the Commission. I asked Mr Roe whether he would be agreeable to conducting an independent analysis of the documents in categories 9 and 10 of the Amended Application to provide:
 - a. a verification that the members who signed the instruments of Authorities were recorded on the membership rolls; and
 - b. the identification of the numbers of members employed in each workplace, employer or lodge in each District Branch. The identification of the workplace, employer or lodge will readily identify those members who would have been eligible for the United Mineworkers' Federation of Australia if it had not been deregistered on 10 February 1992 in connection with the formation of the CFMMEU.
- 25. Mr Roe was agreeable to undertaking such an analysis and providing a report of the outcome.
- 26. In my email to the lawyers of the CFMMEU which is annexure PJP8 I advised of my above discussion Mr Roe and that he was agreeable to conducting an independent analysis and providing a report to the parties. I advised that the exercise would be at no cost to the CFMMEU and would ensure the privacy of the members of the Mining and Energy Division. It would further obviate the need for the CFMMEU to have access to the membership rolls. The lawyers of the CFMMEU have provided no explanation as to why Mr Kelly's proposal has been rejected (see PJP8).
- 27. I am advised by Mr Roe that he is still available to conduct such an analysis.

- 28. I am instructed by Mr Roe that the analysis could be conducted within a period of 2-3 days.
- 29. I am advised by Mr Roe that he is available to conduct the analysis on Thursday 24 and Friday 25 November 2022. If a third day becomes necessary (which Mr Roe and I consider to be most unlikely), Mr Roe has advised me that he is available to finalise the analysis on Tuesday 29 November 2022.



About the F52 application form

Application for an order for production of documents, records or information to the Commission

About orders for the production of documents etc to the Fair Work Commission

The <u>Fair Work Act 2009</u> allows the Fair Work Commission (Commission) to inform itself in relation to a matter before it by requiring a person to provide copies of documents or records, or to provide any other information to the Commission. A party can apply for an order requiring a person to produce documents, records or other information to the Commission.

The application must be accompanied by a draft order. The template for the draft order is attached to this form.

A person is only required to produce documents which are in their possession, custody or control; they are not required to create documents to comply with an order.







A copy of any document recording or comprising the analysis undertaken by each District Secretary (or other officer including Mr Kelly) to identify which members of each District Branch were also eligible to be members of UMFA (as at paragraph 8 of the Second Statement of Grahame Patrick Kelly dated 24 October 2022).
