Dear Associate,

I refer to the above matter and paragraph [89] of the Full Bench decision of 16 July 2021 ([2021] FWCFB 4144), where the Full Bench confirmed their provisional view that cl 50.1 of the Pastoral Award requires variation and indicated that "a conference of the relevant parties will be convened shortly to finalise the content of the variation."

Can I confirm that this aspect of the matter (i.e. in relation to cl 50) has not progressed any further?

I am aware that the balance of the changes to the Pastoral Award were addressed in the draft determination which issued on 22 July 2021 and subsequently finalised on 23 August 2021 ([2021] FWCFB 5198]). The draft determination indicated at paragraph 10 that "[Amendments to clause 50.1 (and any consequential amendments) to be inserted]" but so far as I am aware there has been no further progress on that issue.
