Expense-related allowances.

- A. Pursuant to s.157 of the *Fair Work Act 2009*, the above award is varied as follows:
- 1. By deleting the amount "\$16.53" appearing in clause 19.3(a)(ii) and inserting "\$16.91".
- 2. By deleting the amounts "\$16.06" and "\$30.40" appearing in clause 19.3(b) and inserting "\$16.76" and "\$31.72" respectively.
- 3. By deleting the amounts "\$0.80" and "\$0.27" appearing in clause 19.3(d)(i) and inserting "\$0.92" and "\$0.31" respectively.
- 4. By deleting the table appearing in clause C.2.1 and inserting the following:
