## AMENDED TIMETABLE & DIRECTIONS ISSUED RE COPIED STATE AWARDS

- [1] The timetable for the Annual Wage Review 2022–23 (2022–23 Review) was confirmed in a <u>Statement</u> issued on 4 November 2022 (November Statement).
- [2] The November Statement noted that the Expert Panel will hold a preliminary hearing in March 2023 to allow for full argument as to how the Expert Panel should deal with copied State awards.<sup>1</sup>
- [3] The copied State awards matter was listed for mention on Tuesday 13 December 2022.
- [4] Further to the mention, the following directions are made:
  - 1. Interested parties are to file written submissions in relation to how the Expert Panel should deal with copied State awards by 4:00 pm (AEDT) Friday, 17 February 2023.
  - 2. Any submissions in reply are to be filed by 4:00 pm (AEDT) Friday, 3 March 2023.
  - 3. The matter is listed for mention on Friday, 10 March 2023.
  - 4. The matter is listed for preliminary hearing on Friday, 17 March 2023.
- [5] As set out in direction 4 above, the date listed for the preliminary hearing concerning copied State awards confirmed in the November Statement has been rescheduled.
