A. Pursuant to s 157 of the *Fair Work Act 2009*, the above award is varied as follows:

1. By deleting the amount “\$14.40” appearing in clause 19.3(a)(i) and inserting “\$15.30”.
2. By deleting the amount “\$14.40” appearing in clause 19.3(a)(ii) and inserting “\$15.30”.
3. By deleting the amount “\$14.40” appearing in clause 19.3(b)(i) and inserting “\$15.30”.
4. By deleting the amount “\$14.40” appearing in clause 19.3(b)(ii) and inserting “\$15.30”.
5. By deleting the amount “\$14.40” appearing in clause 19.3(b)(iii) and inserting “\$15.30”.
6. By deleting the amount “\$14.40” appearing in clause 19.3(b)(iv) and inserting “\$15.30”.
7. By deleting the amounts “\$1.93” and “\$9.46” appearing in clause 19.3(c)(i) and inserting “\$1.98” and “\$9.72” respectively.
8. By deleting the amount “\$0.94” appearing in clause 19.3(e) and inserting “\$0.96”.

9. By deleting the table appearing in clause C.2.1 and inserting the following:

Meal allowance—club employees other than club managers—overtime	19.3(a)	15.30	per occasion
Meal allowance—club managers on duty	19.3(b)	15.30	per meal

Clothing, equipment and tools—maximum weekly amount—an amount of up to	19.3(c)(i)	9.72	per week

B. This determination comes into operation on 1 July 2023. In accordance with s 165(3) of the *Fair Work Act 2009* this determination does not take effect in relation to a particular employee until the start of the employee’s first full pay period that starts on or after 1 July 2023.
