Dear Mr Moloney,

I refer to our telephone conversation today in response to your correspondence of 24 March 2016 and wish to confirm the following.

Additional proposed variations

As you are aware, the Full Bench in AM2016/5 has been convened to hear and determine certain matters in relation to the *Ports, Harbours and Enclosed Water Vessels Award* 2010 and the *Seagoing Award* 2010 (see <u>summary of proposed variations</u>).

If Sea Swift wish for other variations to be considered, it should file an application with the Commission in the form of an outline of submissions, identifying any substantive claims or variations being pursued. The written outline should identify the scope of any evidentiary material that is to be filed. It should also indicate whether it submits that the additional proposed variations should be dealt with by the Full Bench in AM2016/5 or a differently constituted Full Bench.

The application should be filed with amod@fwc.gov.au, but addressed to the chambers of Justice Ross, President.

Subscribing to updates

To receive <u>all</u> notifications in regards to the 4 Yearly Review (for example, when notices of listings, notifications, submissions etc. are posted) tick the **All matters** box when subscribing to the award/s. This is a separate service to the Award updates.

If you are a current subscriber to the award you will be notified via the subscription service when the award review page has been updated. To add an award to your subscription, under the <u>Subscriptions</u> tab, select 'My Awards' and use the <u>Search and subscribe to Awards</u> option to find the relevant award/s.

For example, select MA000122 for the *Seagoing Industry Award 2010* and tick the 'award matters' checkbox.

You can also access the Subscription service via the Commission's homepage:
