Dear Associate,

I write in relation to proceedings concerning the finalisation of the exposure draft for the Nurses Award 2010 (AM2019/17).

In preparing Ai Group's reply material in this matter we have identified what we perceive to be potential difficulties associated with the Full Bench finalising the variation determination in the manner proposed as a result of overlap between matters being dealt with in these proceedings and the proceedings associated with Ai Group's application in AM2020/1. We have had brief discussions with both the ANMF and private hospital industry employers associations and there appears to be a level of consensus about such concerns.

Given the circumstances, we request a short extension for the filing of our submission until 11am on Monday, 30 November 2020, to enable us to conclude our discussions with the abovementioned parties and settle our material in light of that engagement. It is hoped that this will enable Ai Group to advance a position in relation to such matters that is substantially agreed between the parties.

I thank the Commission for its consideration of this request.
