- A. Pursuant to s.157 of the *Fair Work Act 2009*, the above award is varied as follows:
1. By deleting the amount “\$15.94” appearing in clause 19.3(a)(ii) and inserting “\$16.27”.
  2. By deleting the amounts “\$15.29” and “\$28.94” appearing in clause 19.3(b) and inserting “\$15.49” and “\$29.32” respectively.
  3. By deleting the amounts “\$0.78” and “\$0.26” appearing in clause 19.3(d)(i) and inserting “\$0.80” and “\$0.27” respectively.
  4. By deleting the table appearing in clause C.2.1 and inserting the following:
