- A. Pursuant to s.157 of the *Fair Work Act 2009*, the above award is varied as follows:
1. By deleting the amount "\$16.27" appearing in clause 19.3(a)(ii) and inserting "\$16.53".
  2. By deleting the amounts "\$15.49" and "\$29.32" appearing in clause 19.3(b) and inserting "\$16.06" and "\$30.40" respectively.
  3. By deleting the table appearing in clause C.2.1 and inserting the following:
