Thank you for your reply.

The ACTU has also seen and considered the correspondence of the AI Group dated 12 February 2024.

We share some of the concerns in that correspondence, especially regarding the fact that parties will not have sufficient time to deal with the literature review in their written submissions. We also note that there is no timeframe for the publication of the survey results, and that it would be helpful if parties were able to address these results in either initial or reply submissions.

We support an alteration to the timetable to address these concerns, but AI Group's proposed timetable raises some concerns for us as some key affiliates would not be available during the proposed consultation period, and the need to minimise overlap with the Annual Wage Review as far as possible.

Accordingly, we would respectfully propose an alternate timetable for consideration as follows:

- Submissions due 19 March
- Submissions in reply due by 4 April
- Consultations to run in the weeks beginning 8 and 15 April, and to be finalised by 19 April.

If the survey results are not available by the time initial submissions are due, we would suggest a direction that parties can comment on the survey results in their reply submissions.

We understand that the timetable will be the subject of further discussions during the Mention on 21 February.
