- 4. The Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia (CEPU) files these submissions in response to the FWC Discussion Paper, *Work and Care*, published on 29 January 2023 ³ (Discussion Paper).
