We refer to the above matter. As you know, we act for the Applicant, Virgin Australia Regional Airlines (VARA).

We are instructed respectfully to request that the hearing set down for Friday, 21 July and Monday 24 July 2023 be adjourned on the following basis:

- bearing in mind some of the matters set out in the statement of Mr Purvinas, filed on Friday, 14 July 2023 and while noting that VARA does not accept many of the matters set out therein, in the interests of a final attempt to determine whether employees are prepared to approve an enterprise agreement, VARA is prepared to put a revised agreement to a vote of employees as expeditiously as possible; and
- VARA has liaised with the ALAEA regarding point 1 above, including the terms of the
 agreement to be put to a vote, the basis on which it is being put and whether the ALAEA
 will support that agreement.

VARA requests that the hearing be postponed for a period of no less than four weeks to allow that vote to take place (which would include our client not being required to file reply evidence today).

We note that the ALAEA has informed us that they do not consent to the adjournment of the proceedings on the above basis, but consents to VARA writing to the Commission to seek an adjournment. We respectfully suggest that the ALAEA articulate its position on the request to the Commission and that the Commission can then determine whether to grant the above request on the basis of the materials before it.
