## Re. Application to vary the Nurses Award 2010

We enclose an application made by the Australian Industry Group (**Ai Group**) to vary the *Nurses Award* 2010, pursuant to ss.158 and 160 of the *Fair Work Act 2009*. The application is filed further to proceedings regarding associated matters before His Honour, Justice Ross, on 9 October 2019.

Ai Group understands that the application is supported by:

- 1. The Australia Private Hospitals Association;

- 3. The Australian Private Hospitals Association New South Wales Branch;

We respectfully propose that the matter be listed for a directions hearing, during which interested parties are provided with an opportunity to be heard as to how the matter should be timetabled.
