We refer to the above matter.

Pursuant to the directions made on 22 May 2020, the Shop, Distributive and Allied Employees' Association was required to file its outline of submissions and evidence upon which it intended to rely by 5.00 pm today, Friday, 3 July 2020.

Regrettably, the SDA has not been able to finalise its material in the allocated time. The work is significantly advanced and we are instructed that it anticipates being in a position to file its material shortly but from an abundance of caution in terms of engaging with complications flowing from continuing and potentially re-engaged COVID-19 self isolation issues, we are instructed to seek a further extension of 3 weeks (to Friday, 24 July 2020) to fully finalise its material.
