- 5. By deleting the amount "\$12.50" appearing in clause 17.4(a)(i) and inserting "\$13.03".
- 6. By deleting the amount "\$25.07" appearing in clause 17.4(a)(ii) and inserting "\$26.14".
- 7. By deleting the amount "\$0.91" appearing in clause 17.4(b)(v) and inserting "\$0.95".

8. By deleting the table appearing in clause B.1.1 and inserting the following:
