Expense-related allowances.

- A. Pursuant to s 157 of the *Fair Work Act 2009*, the above award is varied as follows:
- 1. By deleting the amounts "\$727.66" and "\$842.56" appearing in clause 17.3(b)(i) and inserting "\$759.38" and "\$879.28" respectively.
- 2. By deleting the amount "\$0.40" appearing in clause 17.3(b)(ii) and inserting "\$0.42".
- 3. By deleting the amount "\$0.91" appearing in clause 17.3(b)(vi) and inserting "\$0.95".
- 4. By deleting the amount "\$15.58" appearing in clause 17.3(c)(i) and inserting "\$16.80".
- 5. By deleting the table appearing in clause 17.3(d)(i) and inserting the following:
