Fair Work Legislation Amendment (Closing Loopholes) Act 2023

Variation of modern awards to include a delegates' rights term

(AM2024/6)

Introduction

- This is a submission by the Commissioner for Public Employment (CPE) in the Northern Territory Public Sector (NTPS) in response to the Fair Work Commission's ("the FWC") statement dated 18 January 2024 relating to The Closing Loopholes Act dealing with terms that must be included in modern awards.
- 2. These amendments provide that the Commission must make determinations varying modern awards so that they include terms for workplace delegates by 30 June 2024.
- The Northern Territory Public Sector Enterprise Award 2016 [MA000151] ("the Modern Award") is the enterprise for the NTPS as established by the *Public Sector Employment* and Management Act 1993 (NT) ("the PSEM Act").
- 4. The CPE supports the inclusion of the proposed Workplace delegates and their rights model clause under section 350C of the Act into the Modern Award.
- 5. The CPE has consulted with the Unions and have received no feedback or comment from them about inclusion of the proposed delegates' rights clause into the Modern Award.

The employees who are covered by the award

6. The national system employees who would be covered by the proposed award are employed within the meaning of public sector employment as set out in paragraph 795(4)(e) of the Act are all those employees employed on behalf of the Territory or an Agency, with the exception of Executive Contract Officers, Executive Contract Principals.

Single enterprise

7. Although the NTPS currently consists of 20 agencies it is a single enterprise that is responsible for the following enterprise agreements, The terms and conditions of NTPS employees have been set through legislation and subordinate legislation such as the PSEM Act or By-laws; Public Service Arbitrator determinations; or awards; enterprise agreements; or a combination of instruments and regulation. The following table sets out the current enterprise agreements regulating the terms and conditions of employment of the NTPS.
