Expense-related allowances.

A. Pursuant to s 157 of the *Fair Work Act 2009* (Cth), the above award is varied as follows:

1. By deleting the amount “\$16.40” appearing in clause 19.2(a) and inserting “\$17.48”.
2. By deleting the amount “\$0.95” appearing in clause 19.3(b)(iv) and inserting “\$0.98”.
3. By deleting the amount “\$16.40” appearing in clause 19.5(b)(i) and inserting “\$17.48”.
4. By deleting the amount “\$13.55” appearing in clause 19.6(a) and inserting “\$13.86”.
5. By deleting the table appearing in 19.6(b) and inserting the following:

Year of apprenticeship	\$ per week
Level 1 or 1st year	5.88
Level 2 or 2nd year	7.59
Level 3 or 3rd year	10.46
Level 4 or 4th year	12.14

6. By deleting the amount “\$19.45” appearing in clause 28.7(c)(i) and inserting “\$20.73”.

7. By deleting the amounts “\$212.12”, “\$0.25”, “\$235.73” and “\$0.28” appearing in clause 28.7(d)(ii) and inserting “\$219.64”, “\$0.26”, “\$244.09” and “\$0.29” respectively.
8. By deleting the amount “\$0.95” appearing in clause 28.7(d)(vi) and inserting “\$0.98”.
9. By deleting the table appearing in clause C.1.2 and inserting the following:

10. By deleting the table appearing in clause C.2.2 and inserting the following:

Meal allowance—vehicle salesperson—motor show, agricultural show, or public holiday	28.7(c)(i)	20.73	per midday or evening meal
Meal allowance—vehicle salesperson—showroom or car yard	28.7(c)(i)	20.73	per meal
Use of own motor vehicle allowance—vehicle salesperson—vehicle up to and including 20 hp	28.7(d)(ii)	219.64	per week plus 0.26 per km
Use of own motor vehicle allowance—vehicle salesperson—vehicle over 20 hp	28.7(d)(ii)	244.09	per week plus 0.29 per km
Use of own motor vehicle allowance—vehicle salesperson—Casual use of vehicle	28.7(d)(vi)	0.98	per km
