- A. Further to the decision issued by the Expert Panel in the Annual Wage Review 2022–23 on 2 June 2023 [[2023] FWCFB 3500], the above award is varied as follows:
- 1. By deleting the table appearing in clause 14.2 and inserting the following:

- 4. By deleting the amount "\$128.70" appearing in clause B.2.9(a)(ii) and inserting "\$136.10".
- 5. By deleting the table appearing in clause D.1.1 and inserting the following:
