  4. By deleting the amount “\$15.59” appearing in clause 30.3(c)(ii) and inserting “\$16.81”.
  5. By deleting the amount “\$15.59” appearing in clause 30.5(f)(ii) and inserting “\$16.81”.
  6. By deleting the amount “\$16.78” appearing in clause 54.1(a) and inserting “\$17.52”.
  7. By deleting the table appearing in clause 54.1(b) and inserting the following:
