Expense-related allowances.

- A. Pursuant to s 157 of the *Fair Work Act 2009*, the above award is varied as follows:
1. By deleting the amount “\$0.91” appearing in clause 17.4 and inserting “\$0.95”.
 2. By deleting the amount “\$22.50” appearing in clause 21.8(a) and inserting “\$22.96”.
 3. By deleting the amount “\$14.41” wherever it appears in clause 21.8(b) and inserting “\$15.54”.
 4. By deleting the amount “\$1308.10” appearing in clause 21.8(d)(ii) and inserting “\$1335”.
 5. By deleting the amount “\$12.65” appearing in clause 21.9(b) and inserting “\$15.81”.
 6. By deleting the amount “\$0.91” appearing in clause 21.9(e)(ii) and inserting “\$0.95”.
 7. By deleting the amount “\$0.50” appearing in clause 21.9(f) and inserting “\$0.52”.
 8. By deleting the amounts “\$490.02” and “\$70.05” appearing in clause 21.10(c)(i) and inserting “\$612.43” and “\$87.55” respectively.
 9. By deleting the amount “\$14.41” appearing in clause 21.10(d)(i) and inserting “\$15.54”.

10. By deleting the amount “\$23.34” appearing in clause 21.10(d)(ii) and inserting “\$29.17”.

11. By deleting the amount “\$39.36” appearing in clause 21.10(d)(iv) and inserting “\$49.19”.

12. By deleting the amounts “\$195.28” and “\$27.99” appearing in clause 21.10(d)(v) and inserting “\$244.06” and “\$34.98” respectively.

13. By deleting the table appearing in clause F.2 and inserting the following:
