- 3. By deleting the amount "\$18.50" appearing in clause 18.3(b)(ii) and inserting "\$19.95".
- 4. By deleting the amount "\$18.50" appearing in clause 18.3(b)(iii) and inserting "\$19.95".
- 5. By deleting the amount "\$10.78" appearing in clause 18.3(c)(ii) and inserting "\$11.26".
- 6. By deleting the amount "\$0.91" appearing in clause 18.3(d)(vi) and inserting "\$0.95".
- 7. By deleting the table appearing in clause C.2.1 and inserting the following:

B. This determination comes into operation on 1 July 2023. In accordance with s 165(3) of the *Fair Work Act 2009* this determination does not take effect in relation to a particular employee until the start of the employee's first full pay period that starts on or after 1 July 2023.
