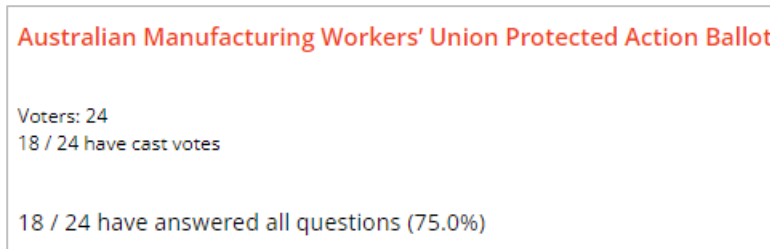

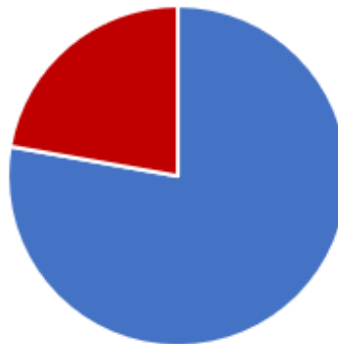

- No - 4 (22%)

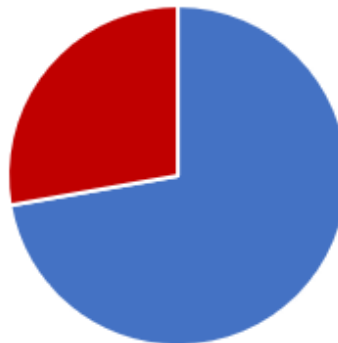

- No - 5 (28%)

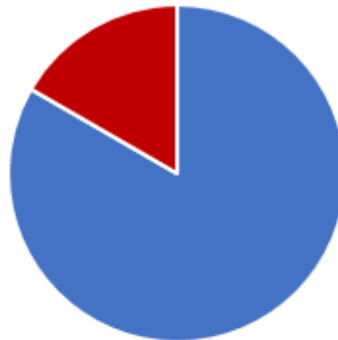

- No - 3 (17%)

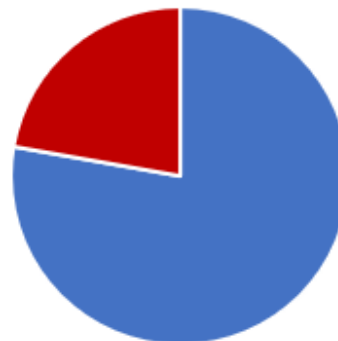

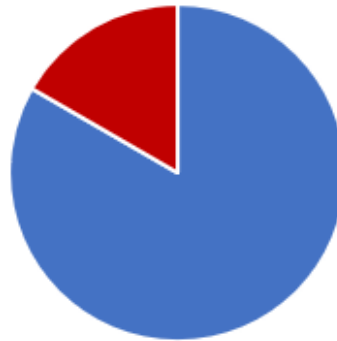

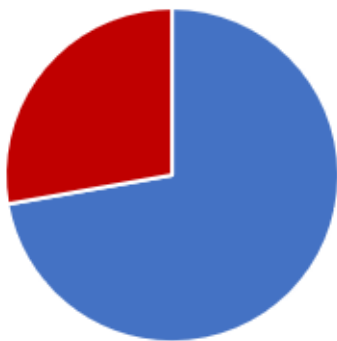

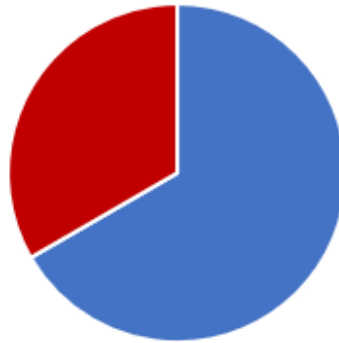

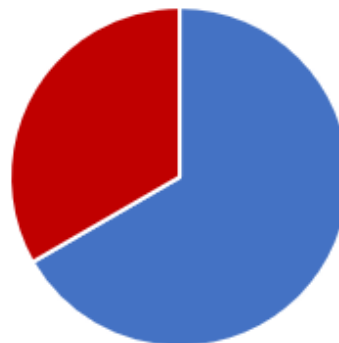
