- 15. An indefinite or periodic ban on contributing to, preparing, or submitting reports.
- 16. An indefinite or periodic ban on issuing invoices.
- 17. An indefinite or periodic ban on the collection of fees, charges, money, or payments for any Serco service.
- 18. An indefinite or periodic ban on fire prevention works.
- 19. Interrupting or stopping work to hand out union flyers to residents and/or other members of the public to place campaign material and display union posters on notice boards and in public areas.
- 20. Interrupting or stopping work to put on or attach to clothing, post and/or distribute union campaign material such as t-shirts, badges, stickers, earmuffs, ear plugs, and written communications.

- 21. An indefinite or periodic ban on performing work in clothes which do not have union campaign material and/or badges attached or performing work in Serco uniforms.
