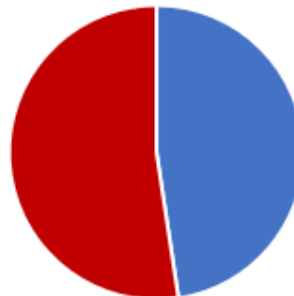

■ No - 22 (52.4%)



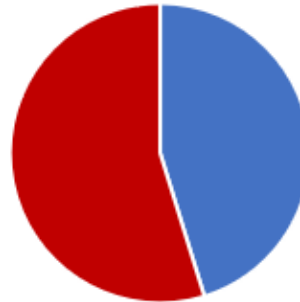
### Question 3
