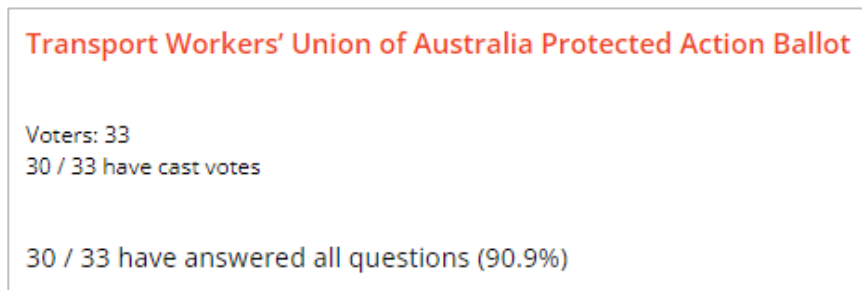

The Transport Workers' Union of Australia Protected Action Ballot has been managed and declared independent of all other parties.

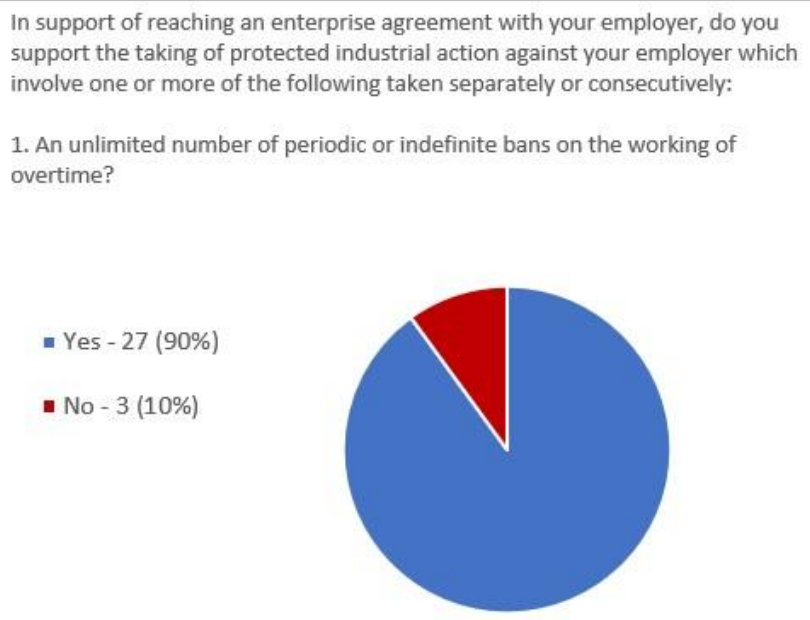

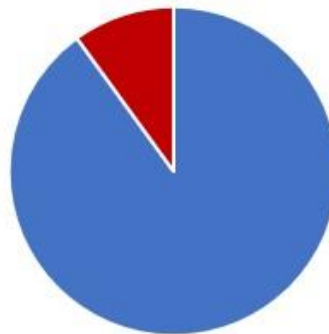

■ No - 3 (10%)



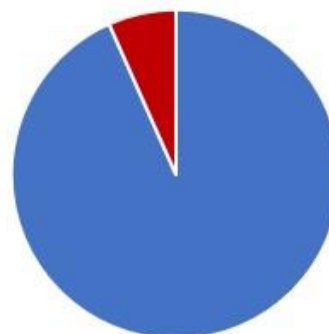

■ No - 2 (7%)



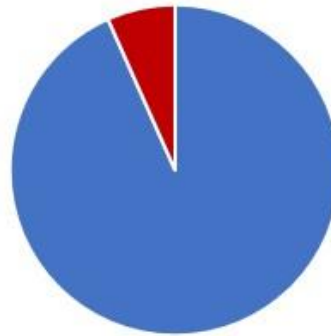

■ No - 2 (7%)



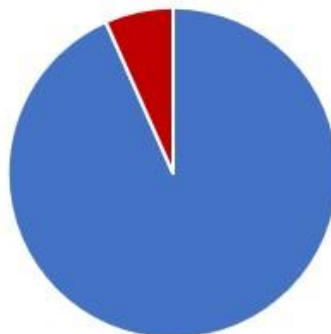

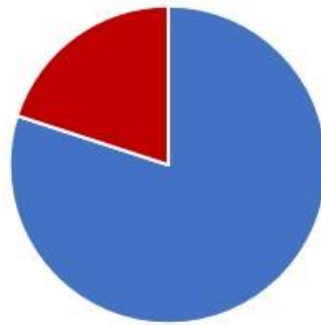
