**Declaration of results - PAB Order: B2022/118**

Pursuant to the Protected Action Ballot Order B2022/118 issued by the Fair Work Commission, the AEC has conducted the protected action ballot and the declaration of the result is provided below.

For the avoidance of doubt, patient in the above 12 questions and exemptions below includes clients, customers, residents, consumers and/or anyone else employees deliver healthcare or services to.

\*Exemptions will apply to

- neo-natal and paediatric patients, haemodialysis patients, maternity patients, oncology patients, palliative care, terminations of pregnancy, intensive care units, coronary care units, high dependency patients.
- emergency admissions provided that such admissions will be into the designated emergency beds.
- emergency matters, where an emergency matter is one where the condition of a patient would deteriorate significantly and pose a serious risk to the health of the patient within 24 hours if diagnosis or treatment did not occur.
