We refer to the correspondence of SDA below. We note SDA did not contact or correspond with the Applicant before approaching Chambers.

The Applicant reached a consent position with Apple on the basis of four grounds.

First, that Apple opposed the application. Until today, Apple had not confirmed its position.

Second, that Apple agreed it would not seek any further extension.

Third, that despite a difference of view of the Applicant, Apple advanced an explanation as to why an extension was necessary.

Fourth, that Apple would not seek an extension for any other person but rather just itself.

SDA has not put any explanation as to its request, nor identified if it opposes the application at all, nor committed to not seeking further delay.

The Applicant does not consent to the request of SDA. The SDA has been on notice of the application for 5 months and had the extant Directions for 8 weeks.
