Hospitality Industry Award (General) 2020 – survey relating to Junior Employees

The Fair Work Commission (the Commission) is dealing with a claim relating to the *Hospitality* (*General*) Award 2020 in matter AM2020/103. The claim relates to junior employees under the Hospitality Award.

Complete this survey if:

- You are an employer
- You have employees covered by the Hospitality Award
- You have junior employees (employees less than 21 years of age)

Please <u>do not complete</u> this survey if you have an Enterprise Agreement in place that covers all of your employees.

You should only complete the survey **once**, regardless of how many times you have received an invitation to complete the survey.

The survey should be completed by a person who knows how many junior employees are employed by the organisation under the Hospitality Award.

What will the survey ask?

We will ask you about **your business and your employees**. The survey includes questions about how many employees you have and how many employees are covered by the Hospitality Award.

We will also ask you about the number of junior employees you have who are covered by the Hospitality Award, and which stream they are employed under (i.e. a 'junior office employee' or 'other than junior office employee')

NOTE: A junior employee under the Hospitality Award is an employee that is less than 21 years of age. (see clause 2 of the Hospitality Award)

Please note the survey DOES NOT relate to apprentices or trainees.

How do I know if my employees are covered by the Hospitality Award?

The <u>Hospitality Award</u> covers employers throughout Australia in the hospitality industry. This includes:

- all types of tourist or residential accommodation including hotels, motels, serviced apartments, resorts and caravan parks
- · wine saloons, wine bars and taverns
- caterers
- casinos
- nightclubs, function areas, convention facilities and restaurants that are connected with an employer covered by the Hospitality Award (e.g. a restaurant at a hotel).

Examples of employers and employees covered by the Hospitality Award include:

- waiters and waitresses
- kitchen hands

- cooks and chefs
- apprentice chefs
- · housekeepers, doorpersons and concierge staff
- front office, clerical and reception staff
- gaming attendants
- security officers and storepersons
- leisure attendants
- · maintenance and gardening staff
- managerial staff who are not senior management
- casino staff including gaming staff, equipment technicians, security and finance officers
- holiday apartment complexes
- catering employees working for a catering business
- pub owners.

If you're still not sure, you can check with the Fair Work Ombudsman.

What will we do with your responses?
